



The GASCalc™ software is our popular suite of analytical tools. Its licensed on a subscription basis. All upgrades and updates are included in the subscription price, as well as technical support - ensuring that you are always working with the latest version of our GASCalc software. Annual subscriptions are purchased per User, with discounts applied for multiple Users.

When purchasing or upgrading to our GASCalc software, a subscription activation fee is due for the first year of use. An annual subscription price per User will then be due on the “Activation Anniversary Date”. If upgrading from a previous version of our GASCalc software, a discounted “upgrade” activation fee is offered. If the subscription is not paid within 30 days of the “Annual Purchase/Upgrade Date”, the subscription will be suspended until paid. If a suspended subscription is not paid within 3 years, the subscription is considered expired, and a new subscription will need to be purchased.

The GASCalc software is delivered by way of electronic download. The software requires a device configured to run Windows™ XP or newer. On the first execution of the software, the User’s device will need to be connected to the internet. After that a license can be checked out for up to 30 days of off-line use, only requiring an internet connection to check for updates or to extend the off-line license.
