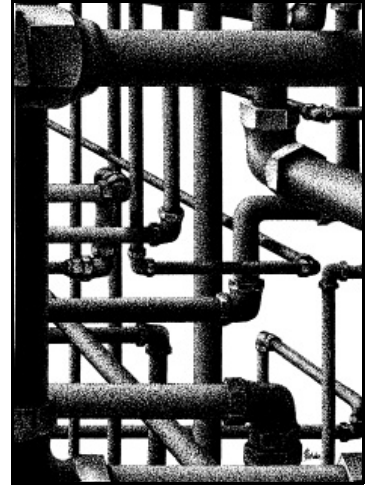


# GASWorkS™ 10.0
